Deviating terms have to be expressly agreed on between us and the client.

Especially concerning so-called net products a separate remuneration agreement comes into place that obligates the customer to pay the fee. Net Products are products where the fees are not included in the insurance premium.

Our company receives additional compensation in form of commissions for the provision of services (for example, guarantee products) and in form of fees for additional services rendered (for example, for the processing of damages caused by third party toward our customers)

The broker does not, directly or indirectly, hold more than 10% of the voting rights or of the capital of an insurance company. In addition, no insurance company or parent company of an insurance company holds, directly or indirectly, more than 10% of the voting rights or of the capital of the Broker's company.
